All sales are made subject to Tarpstop's Terms and Conditions of Sale in effect at the time Applicant's order is accepted. Applicant is responsible for ensuring that all orders made have been properly authorized. Payment is due and payable at Tarpstop within 30 days of the invoice date. Past due accounts are subject to bear interest at the rate of 1.75 percent per month (21% Annual Percentage Rate) or such percentage allowed under applicable law, whichever is less.

Should Applicant fail to make payment(s) (a "Non-Payment"), Tarpstop shall have the right, without notice to Applicant, to declare all invoice amounts immediately due and payable, and to take any actions allowed to Tarpstop under the Uniform Commercial Code, as enacted in the State of Ohio. In the event of any Non-Payment, Applicant does hereby agree to pay and be liable for, in addition to the principal amount due and interest charges, all bank charges and collection charges incurred by Tarpstop, including collection agency fees. In the event of any Non-Payment, Applicant does hereby authorize Tarpstop to charge credit card(s), if held on file at Tarpstop, for the full amounts due Tarpstop. In the event of a lawsuit to collect any amounts due to Tarpstop by Applicant, Applicant agrees to pay reasonable attorney(s) fees and court costs, prior to and subsequent to judgment entered by a court of law, and other expenses incurred by Tarpstop and related thereto.

Applicant expressly waives the right to a jury trial. This Application has been entered into in the State of Ohio and venue shall be in the county of Wood, Ohio. The laws of the State of Ohio (without regard to its principles of conflicts of law) shall govern this Application and any disputes arising between Tarpstop and Applicant relating to the subject matter and contents of this Application.

Applicant wishes to apply for credit with Tarpstop in accordance with these terms and conditions which have been read, understood and accepted. The undersigned warrants that he or she is authorized to represent and bind the Applicant with respect to these matters.
